**1. PRICES AND PERIOD OF PERFORMANCE**

The Contractor shall perform food services work, including furnishing all labor, material, equipment, and services, for the U.S. Embassy Athens Marine Security Guard Residence (MSGR). The price listed below shall include all labor, materials, insurance (see FAR 52.228-4 and 52.228-5), overhead, and profit. The Government will pay the Contractor the fixed price per month for services. Food is purchased separately by Mess NCO (after approval of 30-day menu) and maybe accompanied by the Contractor if needed.

The performance period of this contract is from – July 1, 2021 to June 30, 2022, with four (4) one-year options to renew. The initial period of performance includes any transition period authorized under the contract.

**1.1 VALUE ADDED TAX**

VALUE ADDED TAX. Value Added Tax (VAT) is not included in the CLIN rates. Instead, it will be priced as a separate Line Item in the contract and on Invoices. Local law dictates the portion of the contract price that is subject to VAT; this percentage is multiplied only against that portion. It is reflected for each performance period.
